Financial Report

- The club's accounting is on a cash basis, not accrual, so the financial statements and the year-end taxes don't have to account for any unpaid heating bill problems and any other things like it. The monthly financials need to show what we have not paid for in the last year. Kirby suggests putting some money into an accrual fund each month to avoid having this problem in future years. Interim financials will be more accurate for items such as the heating bill and depreciation.
- Kirby and Terry met with the club's accountant Brenda and the taxes should be done by
 the next meeting. She also can provide the accounting software for \$100 per year. Terry
 informed the board that she does quite a bit of work for the club and thinks she should
 continue to be the club's accountant for a while yet while Kirby and Terry get more
 familiar with the process.
- A year-end and year-to-date P/L will be available next meeting along with a balance sheet. An up to date check register should also be ready by next meeting.
