#### **Old Business**

The Gambling Manager with the Legion wishes to sit down with Richard, our bartender, and one other person prior to the availability date.

Mike Liapis will have two new flags in place in the ice arena area of our club. The old ones have been there many years and will be disposed of properly or used elsewhere.

The dining area has been painted and a new and old array of photos etc. will be hung in the near future. Kirby pointed out that we need better creative lighting of sorts in this area.
