# **Financial Report**

Eric Fenson presented the board with a transaction report, profit and loss sheet, and some other financial info

- The pro shop did well especially considering some of the products didn't arrive in time for the beginning of the season.
- The club made over \$52,000 from memberships and lost about \$2000 from discounts.
- There were about \$25,000 in unique expenses. About \$15,000 of that came from rock payments.

# **GM and Ice Report**

- Eric Fenson would like to put locks on all the open lockers. Then, when someone wants to rent a locker, they will have to pay first. It will also help the club keep better track of locker usage. There were 10 unpaid lockers this past season.
- Eric also suggests raising set up and pitcher prices in the bar
- He would also like to see the kitchen used more often. Myles mentioned he has a couple of ideas for the kitchen but wants to polish them up a bit
- Eric will get a quote on replacing the lower arena wall
- He also wants to get the roof inspected
- The Roller Babes are renting the arena once a week from April 15th through September 15th
- There will probably be 6-10 ice ads available next season, so the club will be looking to fill those. Lanny also mentioned that a thank you letter should be sent to each sponsor and brought up the idea of having a one-day bonspiel for the sponsors.
- Eric would also like to start a fundraiser for the rock payments again. The idea was to do it every year to help pay for the rocks. Tickets could also be sold at the bar.

- Eric is looking at having a Mixed Doubles Bonspiel sometime in December.
- The fire inspection is mostly taken care of
- The USCA and MCA dues have been paid

Painting Projects – Eileen is getting a group to paint the walls of the main stairway on Friday April 19<sup>th</sup>. Eric Fenson mentioned that the brick wall in the arena is also in need of painting.

#### **New Business**

Ownership of Liquor Bottles – There are quite a few bottles claimed by the club that could be used at certain events.

Liquor Laws – The bartenders were wondering what time they should close the bar during bonspiels. Our license states that it should close at 1:00 am.

Babe City Rollers – They will be renting the arena once a week from April 15<sup>th</sup> through September 15<sup>th</sup>. The club will make \$1250 from rent. They had been coming twice a week the last few years and paying \$2500, but their numbers are down.

MCA Spring Meeting May 18 – MCA will have their spring meeting May 18<sup>th</sup> in Blaine. Any board members who can make it are encouraged to attend.

Curling Vendor Conference – This will take place August 8-11. The club doesn't have any interest in attending.

Schenectady Curling Club Donation – The SCC is hoping to receive \$300-\$500 from clubs to help pay for a new plant. The Bemidji Curling Club will not be donating.

USCA Nominations – The USCA is looking for nominations for Volunteer of the Year and Hall of Fame.
